## History

RTU was founded in India in 1978 by Br James Kimpton, a lay brother of the De La Salle teaching order. Starting from a desire to meet the needs of abandoned or orphaned children, RTU now has a team of Indian staff headed by Fr Antony Paulsamy working to help the poorest children and families in many small and impoverished villages around their base - in a rural area of the state of Tamil Nadu. Br James is now retired but still living at RTU and actively involved in identifying communities needing help.

RTU in the UK was begun in 1982 by a small group of friends of Br James, inspired by his dedicated approach and lifetime of commitment. He still uses his skills and insights to enable the most needy - children, adults and the elderly - to find dignity within their own community.

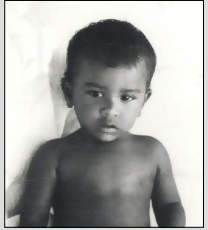
## Achievements

Here are just a few of RTU's achievements. Write to us or visit our website for more information.

- Nearly 1,000 children, many orphaned by AIDS, are cared for in family groups with foster mothers in 4 purpose-built Children's Villages, providing a secure and loving environment. 
- 8 pre-schools cater for over 200 village infants.
- 4 Primary, Middle and Higher Secondary Schools provide education to age 18+ for over 1400 students. Older children are supported through their higher education.
- Three mobile science labs regularly visit 99 government schools in 66 villages, giving students hand-on experience of science experiments. 
- Self-help groups for over 1,500 rural women are facilitated in 28 villages. Loans are given for setting up rural enterprises and for emergency family expenses. An insurance scheme has been set up.
- RTU's clinic has over 33,000 patient visits annually, with another 4000 served by a mobile clinic. Services include mother and baby care; immunisation programmes; HIV/AIDS patient support.
- Many specially designed, concrete-floored and tiled-roof houses are built annually for poor village families. Over 8,600 have been built so far. 
- Bore-wells are drilled. Each can provide water for as many as 200 people; over 2400 have been sunk to date.
- Poor families, including some affected by AIDS, receive monthly assistance enabling over 750 children to be properly fed, and clothed, and kept at school.
